

## DUMPSTER PLACEMENT POLICY

Permission to place dumpster on any street is only to be given if there is absolutely no space on the property, including driveway to place a dumpster.

If a dumpster is placed in a driveway permission to park a vehicle on the street will be given by the Chief of Police if needed to make room for dumpster.

If the dumpster is to be placed on a State or County Highway, permission from the State or County in writing must accompany application request.

Display of yellow reflective diamond shaped markers/panels with a minimum size of 18" x 18" must be mounted at both ends of the dumpster nearest the path facing oncoming traffic.

The police department will inspect all dumpsters on any street in the Borough to see if it conforms to N.J.S.S. 27:51-1. A violation of this State Law if convicted could result in a fine of \$100.00 per violation.

If a dumpster must be placed on a street, application must be made to the Haddon Heights Construction Office accompanied by a \$50.00 fee. No fee is required if the dumpster is placed on private property.

## W A R N I N G

A DUMPSTER PLACED ON ANY STREET IN THE BOROUGH WITHOUT FIRST OBTAINING AN APPROVED PERMIT WILL BE REMOVED AND IMPOUNDED UNDER AUTHORITY OF THE HADDON HEIGHTS POLICE DEPARTMENT.

# GUIDELINES FOR ROLL - OFF CONTAINER MARKINGS

## PARKING OF ROLL-OFF DUMPSTERS

### OR ROLL-OFF CONTAINERS

N.J.S.A. 27:51-1

The above-referenced New Jersey Statute applies only to those "roll-off dumpsters" or "roll-off containers" that are placed on parked on roadways, or along any highway, or along any public property.

#### Purpose

To warn operators of vehicles traveling on public property that they are approaching parked roll-off containers, which require them to exercise unusual care in the operation of their vehicles.

To promote traffic safety on highways or public property

#### Compliance

Must have written consent to park or leave unattended roll-off dumpsters or roll-off containers on or along any highway or public property.

Note: Written consent obtained from appropriate municipal, county or state authority having jurisdiction over the highway or public property in question.

Display of yellow reflective diamond shaped markers/panels with a minimum size of 18 inches by 18 inches.

Marker/panels must be mounted at both ends of dumpsters or containers nearest the path facing oncoming traffic.

Mount marker/panel at the upper end of dumpster or container leaving a minimum height of 3 feet clear distance between bottom of marker/panel and bottom of roadway surface.

#### Penalties

Violation of this statute carries a fine of not more than \$100.00 per violation.

If there is a default on payment of fine, then imprisonment in the county jail may be imposed for period of not more than 90 days.

AN APPLICATION IS HEREBY MADE TO PERMIT THE PLACEMENT OF A WASTE OR REFUSE CONTAINER, COMMONLY KNOWN AS A ROLL-OFF DUMPSTER OR ROLL-OFF CONTAINER ON, OR ALONG THE ABOVE LISTED ROADWAY. I ALSO AGREE TO CONFORM TO STATE LAW 27:51.1 PERTAINING TO UNATTENDED DUMPSTER, ESPECIALLY PERTAINING TO DISPLAY MARKERS OF YELLOW REFLECTIVE DIAMOND-SHAPED PANELS WITH A MINIMUM SIZE OF 18 INCHES BY 18 INCHES. THESE PANELS TO BE MOUNTED AT THE EDGE OF THE DUMPSTER OR CONTAINER AT BOTH ENDS NEAREST THE PATH OF PASSING VEHICLES AND MOUNTING HEIGHTS OF 3 FEET FROM THE BOTTOM OF THE PANELS TO THE SURFACE OF THE HIGHWAY. IF APPROVED THIS PERMIT WILL BE FOR (30) THIRTY DAYS AND MAY BE RENEWED BY APPROVING AUTHORITY. ALL DUMPSTERS WILL BE INSPECTED BY THE POLICE DEPARTMENT FOR CONFORMITY TO THE STATE STATUTES.

ALL DUMPSTERS MUST BE PLACED ON HOMEOWNERS PROPERTY IF THERE IS SPACE AVAILABLE.
