Camden County COVID-19 Vaccination Information

Get Help With Scheduling An Appointment: For help with the New Jersey Vaccine Scheduling System, visit covid19.nj.gov/vaccinehelp or you can call toll-free 855-568-0545.

Scheduling Process Overview:

You will be able to schedule an appointment using a smartphone or computer. Each patient will need their own MyCooper account in order to schedule their appointment. If you do not already have a MyCooper account you can easily create one online. Your second dose appointment will be scheduled at the center while you are receiving your first vaccination.

Step 1: Log in to or create your MyCooper account using your mobile device or computer. <https://www.camdencounty.com/vaccineregistration/>

Step 2: Schedule your vaccine appointment from your MyCooper account.

Step 3: eCheck-In is required to be completed prior to your appointment. This can be done up to 7 days prior to your appointment.

Step 4: Arrive at location no earlier than 15 minutes prior to your appointment.

The Camden County Vaccination Center is open to administer vaccines, Monday-Saturday, 9am to at 4pm Camden County College, 200 College Drive, Blackwood, New Jersey.

You can also email him directly at Vaccine@Haddonhts.com. Be sure to include your full name, birthday, email, phone number, and your current appointment date.

Need a Ride to your COVID Vaccination Appointment?

Schedule a Ride to a Camden County Site or Burlington County Mega Site (Moorestown Mall) for your Covid-19 vaccine.

Eligibility Criteria

- Camden County resident;
- At least 60 years of age or certified handicapped;
- Independent mentally and physically (can use wheelchair or have your own escort); and
- Have an appointment in Camden County or Burlington Mega Site to receive the Covid 19 Vaccine.

Rides are door-to-door, round trip, and based on availability. To request a ride, call the Senior Citizens United Community Services at 856-456-3344, three days to two weeks in advance of your appointment. Reservations are taken Monday – Friday from 9-2. The cost is \$2 for a one way ride of \$4 round trip.

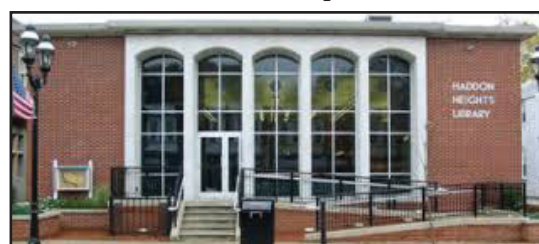
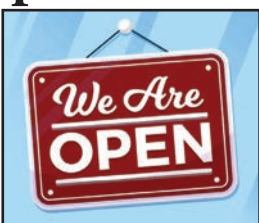

MAYOR'S MESSAGE

Dear Neighbors:

Well, I don't want to jinx us when I say it looks like winter is behind us, but I think I speak for everyone when I say spring cannot come soon enough. On that note, I must give a big shout-out to our incredible public works once again for their plowing work this winter season. With that, many of you may have already taken advantage of some mild weather to start some yard work. Just a reminder, our brush collections for the East Side (10th Ave to Haddonfield) will be Wednesdays, and brush collections for the West Side (10th Ave to the Black Horse Pike — including 10th) will be Thursdays. Also, take note to please not place brush out at the curb in plastic bags.

With the weather finally breaking, you may notice an increase in utility work around town. Devon Ave resurfacing work has begun, which involves new curbs, aprons, and paving from the Borough border with Bellmawr to Prospect Ridge. The second round of funding was secured this year to complete this work and work on St. Martins Avenue. Let me assure you we hear your concerns and agree when it comes to our streets and sewers. That

is why Council has been hard at work taking the information gathered in our small assets management study to put together a comprehensive plan for sewer and street repairs in the future.

On the COVID-19 front, I am happy to report that more and more people are getting vaccinated, and our overall numbers seem to be slowing. I encourage everyone to get vaccinated as soon as possible. In this issue and on the borough's website, you should find a list of locations you can go to schedule an appointment to get vaccinated. If you are over 65 or know someone who is, I encourage you to register at www.CamdenCounty.com/VaccineRegistration/ for an appointment at the Camden County College, Blackwood site. Once registered here, I then prompt you to reach out to me via the email, vaccine@haddonhts.com, or the borough's website form, to request a move up on the County's list. We have had great success to date, moving over 150 senior's appointments within days of their request. We are also happy to assist in any travel issues or special requests.

This year we see a slight return to normal in regards to activities. I've signed my girls up already for spring

sports, and I encourage everyone to take a look at HHYA, HHSC, and our other organization's offerings this year. All of these programs are doing a great job following CDC and State COVID-19 guidelines. I just kindly ask that everyone does their part during our spring season and still practice good social distancing and good hygiene. We are not out of the woods yet. Tentatively, we plan to hold our annual Memorial Day services with some slight modifications to account for COVID-19 precautions. I encourage everyone to mark their calendars for the May 31st observances.

Finally, I wanted to take a moment to remember Jackson Sadlowski, a vibrant 7th grader we lost far too soon in March. I cannot begin to tell you how encouraged I was during such a tragedy by the way our small town rallied to support the Sadlowski family and our community as a whole. In Jackson's memory and honor, the Sadlowski family has courageously made it their mission to lower the stigma around openly talking about mental illness and we all must join them in their efforts. know someone is struggling, I encourage you to reach out to someone, anyone, and share. You never know how your sharing will allow someone else to open up, feel comfort or find answers. We are #HeightsTogether.

As always, please look for more frequent updates from us at Mayor on Council by following along on social media, our website, and ultimately joining us for a Council Meeting on the First and Third Tuesdays of the month. They are currently conducted by zoom with the link found on the Borough website, and we hope to return in person very soon.

Please cooperate with the Assessor's inspector who will perform an interior and exterior examination of your home or business, and request information to confirm the type of work done, or to be done, the cost of the project, and the date the job was, or is to be completed. This inspection is in addition to any inspection(s) required by the Haddon Heights Building Inspection Department.

The inspector will visit your property unannounced in the day, early evening, or on a Saturday. This method of inspection is very cost effective and I greatly appreciate your help allowing the inspector to collect the data required. Requirement of Animal Licensing

Registration is Required for all Dogs and Cats!

It is the law and mandatory that dog and cat owners have their pets licensed. Licenses are good for one calendar year and must be renewed annually. License tags must be displayed on animals at all times.

Benefits of having your animal licensed and vaccinated include making it easier for your pet to be identified and returned to you should they get out. Even indoor cats have been known to escape at times, without a license whoever finds your pet will have a harder time identifying them and they may not be returned to you. If they did escape they would be protected from Rabies should they be bitten by a wild animal living outside. If we get all of our animals vaccinated against rabies, then no parent will have to be afraid that one of their children may be bitten by a rabid cat or dog.

Animal License Renewal Letters have been mailed out for 2021 renewals. If you did not receive your letter or need a new one, please visit www.haddonhts.com, under Forms & Permits or you can contact the Borough Administration Office.



In order to get your animal licensed for the 2021 calendar year the office staff will need to see your pet's proof of rabies vaccination. **The vaccination will need to be good through November 2021 for a license to be issued.** The cost for a spayed/neutered cat or dog is \$9.00. The cost for a non-spayed/non-neutered cat or dog is \$12.00.

License Fees support the efforts of many local animal shelters. Typically, the annual fee that you pay to license your pet helps to keep shelters running and support the work of your local animal control.

Pet owners should also be aware that the State of New Jersey recently passed State Statues pertaining to Animal Cruelty. The information can be found at the New Jersey Department of Health website (www.state.nj.us/health) for the State Statues listed below.

FREE Rabies Vaccine Clinic

The Borough of Haddon Heights Local Board of Health and Camden County Board of Health are once again offering a free rabies clinic to be held in the Spring on **Saturday, April 24th, 8:30am - 9:30am**. The clinic will be held at the Haddon Heights Fire Department located behind the library at 608 Station Avenue, Haddon Heights.

If your pet is in need of updating their vaccination, you can attend at no cost. Both residents and non-residents are welcome. Residents will also be issued their 2021 pet license(s) at the event.

Haddon Heights Environmental Updates

Borough Council has funded the site testing, which is a prerequisite to remediation of the solid waste facility at Devon and Walnut behind the tennis courts. Once the results are in, Council will be able to apply for a New Jersey Environmental Brown Field State Grant for the site remediation.

The first step to Aggregation of Residential Electric Energy is to join a cooperative. Borough Council will then pass a Resolution and Ordinance to capture data on electric usage and obtain bids for fixed pricing on energy. The results will be lower electric bills for residents and a lowering of carbon footprint from the current 22% of renewables to 40-50% with green energy. Pricing will not be variable; it will be in fixed term.

Borough Council is currently working with the Station Avenue business community to improve street lighting to newer LED fixtures. Many lights need repair and replacement. Once the proper historically approved fixture is selected, we will move forward with this project.

Council is working on the feasibility and funding of an irrigation well at the Devon Avenue Athletic Fields. Once funded and installed, will result in savings on irrigation costs and improve field conditions.

The Shade Tree Commission would like to plant 100 trees to increase the tree canopy in the fall. Please help in financing this project with your donations of \$85.00 per tree. If you would like to get on the planting list, please contact them at on the borough website.

Heights Grows has worked to improve our town with new planters and town cleanup. Many thanks for there efforts. In March Heights Grows will be undertaking a fundraiser to support the planting costs and upkeep of the beautiful planters on Station Ave. A sponsorship is expected to cost \$200.00 for the year. 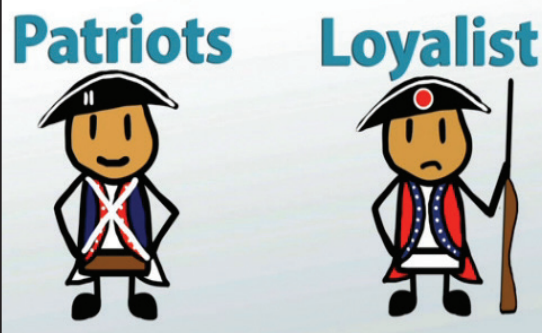

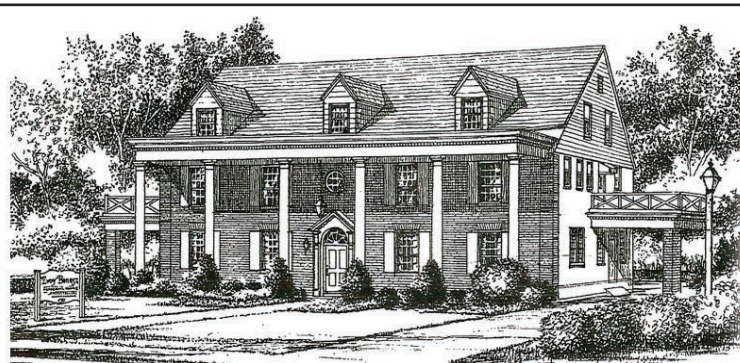

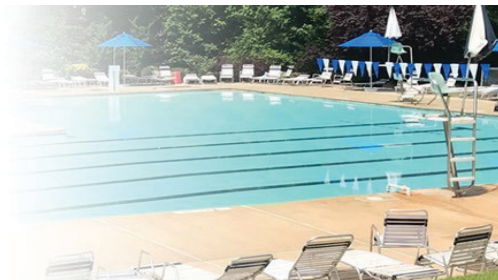

123rd Anniversary Celebration

February is "Anniversary Month" at Haddon Heights Baptist Church and this year the borough's first church, founded in 1898, four years before the borough's incorporation, celebrated its 123rd year of existence.

Anniversary Sunday this year was February 28th, a day two weeks short of a year from the last worship service the church gathered for before the country's houses of worship were required to suspend meetings due to the pandemic. HHBC shifted to online worship and Bible Study events until the ban was lifted in June of 2020, but indoor food events have been few and small until this year's anniversary luncheon. It felt like a return to near-normal to gather and fellowship and celebrate the passing of a most unusual year along with the 123rd anniversary.



Restaurant-like protocols were followed, with good food and great memories of the church's earlier days that muted the more recent difficulties of the year of the pandemic.



Another anniversary that coincided with HHBC's 123rd was the two-year anniversary of the arrival of Pastor Erik Christensen and his wife Stephanie. A recognition of the occasion at the anniversary luncheon noted their leadership in navigating the church through the turbulence of the last year-plus.

As of March 1, 2021, the State of New Jersey is allowing houses of worship to gather indoors up to 50% of seating capacity. This will allow Haddon Heights Baptist Church much greater latitude in planning services, meetings, ministries and events. As a result, Sunday and Wednesday schedules will be reconfigured beginning in September as follows:

Club activities have been paused due to the pandemic and, at present, are scheduled to resume in September, 2021. At that time, clubbers will meet on Sunday evenings from 6:00-7:30 pm. This big change of day and time has been made to better accommodate families who have found it challenging to ferry clubbers to and from club at the end of a busy work/school day and get them in bed at a reasonable hour. Hopes are that the lighter weekend schedule and earlier start/finish will relieve family stress and lead to a more positive club experience. Clubbers and leaders alike greatly miss club meetings and anticipate the reopening this Fall.

Awana, which stands for Approved Workmen Are Not Ashamed, is a kids club for children age 3 through 6th grade. Emphasis is on wholesome game activities, Scripture memorization and Bible-based teaching. Awana will meet Sundays, September through April, from 6:00 pm to 7:30 pm.

Easter Services

The Good Friday service on April 2 will begin at 7 pm. There will be no Easter Sunrise service on April 4 for the second straight year due to pandemic concerns. Long an Easter morning tradition at the Haddon Heights Dell, hopes are high that 2022 will see a resumption of that very special service. This year's Easter service begins at 11:00 am in the Main Auditorium.

Youth Group

The church's Jr/Sr High Youth Group meets on Wednesdays from 7:00 pm to 8:30 pm year round. Come for food, fun, fellowship, a challenging speaker, good music and games.

Day of Prayer & Granny Club

Haddon Heights Baptist Church believes that a foundational reason the church has been in existence for 123 years is the commitment of its members to praying for one another. Wednesday Prayer Meeting has been in existence for all of those 123 years. Spreading God's Love through our Food Pantry

In every church I have served during the past 30+ years, there has been a food pantry. Growing up in a small coal mining town where employment was often lean, I learned how important pantries were – both to those who received AND to those who donated. People shared willingly and lovingly... everyone was richer because of the experience. I have been blessed to again be involved through Fellowship's pantry – getting to know those who come for help and coming to love more dearly my own church family members who give out of their love for God's children.

One family shared a moment with me that touched me deeply, reminding me that sometimes it's the simplest things that mean the most. This family has children, and their parents work hard to provide healthy meals. They ask for very little but are extremely grateful every time they come to our pantry. During one visit I asked if there was anything else the mom could think of that she needed for her family. She said it wasn't a real "need" but wondered if we had something she

could use as a healthy treat in the kids' lunches. I asked if they liked raisins, as someone had thoughtfully donated packs of the small boxes. There was silence on the other end of the phone. Then I realized she was crying. She explained that as a child her mother had put those same boxes of treats in her lunches that always made her feel special – and now during COVID and a tightly stretched budget, she could not do the same for her children. She was brought to tears by the small gesture that would allow her to feel more like the mom her own mother had been by bringing a smile to her own children's faces as they shared lunch together. I quickly packed four six-packs of little boxes of raisins in her order.

Just a box of raisins?? No, it was a large dose of God's Love from some other mom/dad/grandmom or gramps who remembered how it feels to be able to see the joy in the faces of your child or grandchildren even during the toughest of times. It was a gift of respect and understanding for a family trying to do their best for their children and being willing to trust that they would be treated as the treasured human beings they are by a church that they didn't know.

It was in that moment that I was the most blessed of all – being able to be part of a ministry that included an incredibly amazing Christ-inspired church family as well as community neighbors who were willing to risk their deepest thoughts and needs to total strangers!

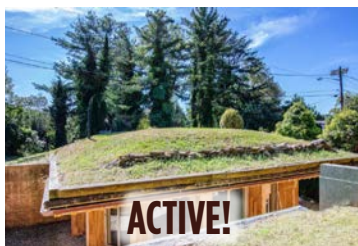

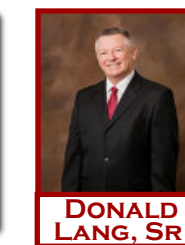

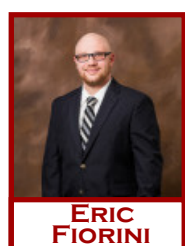
