

Requirement of Animal Licensing

Registration is Required for all Dogs and Cats!

It is the law and mandatory that dog and cat owners have their pets licensed. In order to get your anima for the 2022 calendar year

and cat owners have their pets licensed. Licenses are good for one calendar year and must be renewed annually. License tags must be displayed on animals at all times.

Benefits of having your animal licensed and vaccinated include making it easier for your pet to be identified and returned to you should they get out. Even indoor cats have been known to escape at times, without a license whoever finds your pet will have a harder time identifying them and they may not be returned to you. If they did escape they would be protected from Rabies should they be bitten by a wild animal living outside. If we get all of our animals vaccinated against rabies, then no parent will have to be afraid that one of their children may be bitten by a rabid cat or dog.

Animal License Renewal Letters have been mailed out for 2022 renewals. If you did not receive your letter or need a new one, please visit www.

> haddonhts.com, under Forms & Permits or you can contact the Borough Administration Office.

In order to get your animal licensed for the 2022 calendar year the office staff will need to see your pet's proof of rabies vaccination. The vaccination will need to be good through November 2022 for a license to be issued. The cost for a spayed/neutered cat or dog is \$9.00. The cost for a non-spayed/non-neutered cat or dog is \$12.00.

License Fees support the efforts of many local animal shelters. Typically, the annual fee that you pay to license your pet helps to keep shelters running and support the work of your local animal control.

Pet owners should also be aware that the State of New Jersey recently passed State Statues pertaining to Animal Cruelty. The information can be found at the New Jersey Department of Health website (www.state.nj.us/health) for the State Statues listed below.

On April 24, 2022, 400 free seedlings will be to undertake an investigation to determine distributed by the Shade Tree Commission, Haddon Heights at the Farmers Market provided by the NJ State Forestry Program. Shade Tree Commission seeks curb line locations for this year's planting. Please contact ShadeTree@haddonhts.com with tree requests. We expect to plant 100 trees in 2022. Last year 80 new trees were planted.

PSE&G has installed new LED streetlights to improve our downtown district. Older lighting was frequently failing and the Mayor and Council, spearheaded by Councilman Tom Ottoson, worked diligently to find an economical solution. Councilman Ottoson and HiP along with PSE&G were able to make the needed improvements at no additional expense to the Borough. The new lighting provides more efficient energy consumption and a small savings to the taxpayer.

The community bike rack project received many contributions from residents and businesses. The racks will be installed this spring in the business district. Thanks to our sponsors as this project could not move forward without your support!

It is the time of the year when Council is developing the annual budget. Additionally, we continue to work on putting a plan in place for further infrastructure improvements. The Engineering Committee has several exciting projects scheduled for construction during the summer / fall construction season. The first is the Haddon Heights Road Program to repave and reconstruct portions of four streets in town - 11th Avenue, Maple Avenue, Bradshaw Avenue and First Avenue. While there are many streets that are in town in need of repaving, we are excited to be able to chip away at some of those in need and look forward to being able to repave more in future years. The second is to construct a recreational trail from the Norcross-McLaughlin Memorial Dell to Prospect Ridge Blvd. The last will involve replacement of almost 100 handicap ramps at roadway intersections that are in close proximity to Borough schools and parks. This will improve the accessibility for all community members to these valuable community assets. For more information on these and other Borough projects, please check out the engineer's status update in the agenda packet for each Borough Council Business

In June 2021, Borough Council adopted a Resolution directing the Planning Board

whether certain property in the Borough Environmental Commission and Sustainable meets the criteria for an Area in Need of Redevelopment or an Area in Need of from 9:00am until 12:00 noon. The trees are Rehabilitation without the use of eminent domain. The Borough property subject to the investigation is located in two distinct areas, one along S. Black Horse Pike and one along S. White Horse Pike and Station Avenue. Bob Melvin, a licensed professional planner with the engineering firm Pennoni, undertook the investigation and prepared a report of his findings and recommendations that was presented at a Special Planning Board public hearing on February 22, 2022. At the meeting, the Planning Board approved the recommendations and passed a resolution designating the relevant properties as Redevelopment or Rehabilitation areas. The next step is for a plan to be prepared that will outline the goals for the Redevelopment or Rehabilitation areas. The Planning Board, Historic Preservation Committee, and the general public will have opportunities to weigh in throughout the process. This is an exciting time and we look forward to the future growth and progress of our town. 

Environmental Commission

The State of New Jersey passed legislation for a plastic bag "ban" effective May 4, 2022. The ban affects most stores, including grocery, clothing, "big box" stores and restaurants. Large stores (like John's Friendly Market and ShopRite) are not allowed to use paper bags. Small stores can continue to use paper bags. Residents will need to bring reusable bags to most shopping locations. Smaller bags used for lunch meat, cheese, vegetables, rolls, etc. will still be used.

New Jersey residents will be needing millions of reusable plastic bags starting May 4. It is suggested that residents plan for this change by obtaining reusable bags as soon as possible.

The State of New Jersey has prepared a list of rules, which can be found on the Borough website on the Environmental Commission tab.







Kings Run Condominiums has done well during the Covid epidemic and not lost one of its residents to the virus. One of its two-bedroom units sold this past month, the first sale in two and a half years. The owner is moving back to her hometown of Collingswood!

Kings Run is an independently owned condominium association for independent people; it's not assisted-living nor connected with Stanfill Towers. 


