2024 Annual Reorganization Meeting

Haddon Heights hosted its annual re-organization meeting on Saturday, January 6, 2024. In attendance was a large group of dignitaries, professionals and the public. Re-elected Mayor Zachary Houck and re-elected Councilwoman Regina Philipps were sworn in by Senator Nilsa Cruz-Perez. Councilwoman Kate Harron, who was previously selected to finish the remaining term of former Councilwoman Trisha Egbert, was sworn in by Assemblyman William Spearman. Councilwomen Philipps and Harron join current council members Chris Morgan, Tom Ottoson, Kate Russo and Matt Pagan.

The newly-formed Council proceeded to work through its agenda. Councilman Chris Morgan was sworn in for a third term as Council President. Department directors were appointed, namely Councilwoman Kate Harron to Parks & Recreation; Council President Chris Morgan to Public Works; Councilwoman Kate Russo to Finance; Councilman Tom Ottoson to Construction/Zoning and Councilwoman Regina Philipps to Administration and Public Safety. The Council

also re-appointed various professionals, including Howard C. Long, Esquire of Wade, Long, Wood & Long as Borough solicitor and Bach Associates as Borough engineer.

One of the most important parts of the morning was the swearing-in of dozens of Haddon Heights' residents who will lend their valuable time to support the town's various committees, commissions and groups. Volunteers will assist with the Municipal Drug Alliance, Environmental Commission, Green Team, Planning & Zoning Board, Historical Preservation Commission, Civic Events Committee, and Shade Tree Commission-- just to name a few of Haddon Heights' important organizations. The Borough Council truly appreciates the community involvement and encourages all residents to get and stay involved.

Happy 2024 to everyone in Haddon Heights. I am eager to begin my second term as your Mayor. I want to thank everyone who came out for our annual Reorganization Meeting in January where Councilwoman Regina Philipps, Councilwoman Kate Harron, and myself all took our oaths of office. I also want to thank all of our volunteers and professionals who also took their oaths of office to serve our great Borough. We couldn't do this without you, so thank you for your service.

With a new year means new projects and initiatives. I am excited to see the Council focus on a couple of key areas. Councilman Ottoson is working hard to bring remediation to the Devon Avenue Fields beyond the Tennis Courts. He is working closely with our Engineer, our outside LSRP, and the State to remediate these sites so we can begin to look at using them for additional recreational fields. I applaud Councilman Ottoson's steadfast dedication to this project. Our Engineering committee, headed up by Councilwoman Russo and Council President Morgan, is once

again concentrated heavily on not just paving roads throughout the Borough but also beginning some long overdue sewer projects. Parks & Recreation, headed by Councilwoman Harron & Councilman Pagan, is also pleased to begin a soil project at the girls' softball fields located on W. Atlantic Ave. These fields have had drainage issues for some time and we are happy to find ways to rectify these issues and invest in improving these fields for our young athletes. Finally, Councilwoman Philipps, Councilwoman Harron, and myself are enthusiastic to continue to work on redevelopment and rehabilitation projects throughout the Borough. We have a number of projects in the works are excited to showcase them as they progress. Please check the Borough website for more information on these projects.

I am also happy to announce that at the close of 2023 the Public Safety Committee was able to solidify a Shared Service Agreement between the Boroughs of Runnemede, Barrington and Heights for Emergency Medical Services. Our three communities are

working hard to optimize the response of EMS to our towns while also ensuring fiscal responsibility. We are proud of the services we are offering and look forward to our continued partnership. We are also pleased to see a renewal of our Fire Department Shared Service Agreement. This partnership with the Borough of Barrington allows us to guarantee a rapid-fire engine response Monday through Friday during the day when the apparatus is staffed with a minimum of three firefighters. We continue to look at opportunities to expand the coverage while still relying on our dedicated volunteers to support the overall operations. Speaking of our volunteers, I want to thank them for several quick responses in town and to our neighbors in Audubon for devastating fires. We cannot thank you enough for serving and protecting our communities.

Now I know the weather continues to remind us that we are in the dead of winter, but take a look through this issue for important spring sports registration dates. Before you know it, it will be Spring, with spring soccer,



softball, baseball, lacrosse, and more underway. I know HHYA & HHSC is always looking for more coaches and volunteers so please reach out. 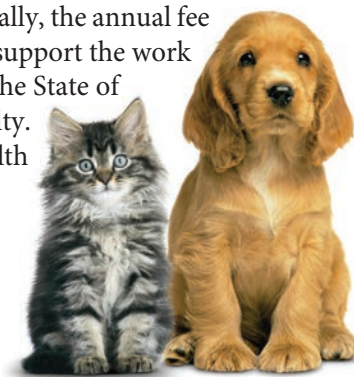
Registration is Required for all Dogs & Cats

It is the law and mandatory that dog and cat owners have their pets licensed. Licenses are good for one calendar year and must be renewed annually. License tags must be displayed on animals at all times. Benefits of having your animal licensed and vaccinated include making it easier for your pet to be identified and returned to you should they get out. Even indoor cats have been known to escape at times, without a license whoever finds your pet will have a harder time identifying them and they may not be returned to you. If they did escape they would be protected from Rabies should they be bitten by a wild animal living outside. If we get all of our animals vaccinated against rabies, then no parent will have to be afraid that one of their children may be bitten by a rabid cat or dog.

Animal License Renewal Letters have been mailed out for 2024 renewals. If you did not receive your letter or need a new one, please visit www.haddonhts.com, under Forms & Permits or you can contact the Borough Administration Office. In order to get your animal licensed for the 2024 calendar year the office staff will need to see your pet's proof of current rabies vaccination. **The vaccination will need to be good through November 1, 2024 for a license to be issued.** The cost for a spayed/neutered cat or dog is \$9.00. The cost for a non-spayed/non-neutered cat or dog is \$12.00.

License Fees support the efforts of many local animal shelters. Typically, the annual fee that you pay to license your pet helps to keep shelters running and support the work of your local animal control. Pet owners should also be aware that the State of New Jersey recently passed State Statues pertaining to Animal Cruelty. The information can be found at the New Jersey Department of Health website (www.state.nj.us/health) for the State Statues listed below.

The Borough of Haddon Heights Local Board of Health and Camden County Board of Health are once again offering a free rabies clinic to be held in the Spring on **Saturday, April 27th, 8:30am - 9:30am**. The clinic will be held at the Haddon Heights Fire Department located behind the library at 608 Station Avenue, Haddon Heights.

If your pet is in need of updating their vaccination, you can attend at no cost. Both residents and non-residents are welcome. Residents will be issued their 2024 pet license(s) which will be then mailed with their 2024 animal tag the following week. Please bring a check or exact change.

Councilwoman Philipps read the Planning Board recommendations bicycle racks should be consistent with existing bicycle racks. The other recommendation is to reexamine the setback to be consistent with other buildings on the White Horse Pike. We need an accessible building. The setbacks have been reexamined; there are no other feasible options. Amendment to include the bicycle racks suggestion but unfortunately the setbacks cannot be altered because there would be issues with building accessibility and/or on-site parking.

Philipps added that the developer has been very willing to work with us all aspects of the process including the facade of the proposed building.

Council congratulates Julie Yuhaze, who has received the well-deserved promotion to the position of Borough Deputy Clerk. Council also welcomes the Haddon Heights-Barrington Fire Department's newest career firefighter, Tyler Jackson. The Borough is happy to announce it will be extending its Shared Services Agreement with Barrington for fire services. The Borough also is excited to announce the execution of a Shared Services Agreement with Barrington and Runnemede for EMS services. These shared services provide consistent, reliable emergency services to our residents at a reasonable cost. The Borough is also pleased to have its Police Department's officers, Captain and Chief under new contracts. Council always is grateful to their first responders for their efforts in continuously serving and protecting our community.

Construction at the intersections of Station Avenue with East and West Atlantic Avenue made significant progress this Fall. In December, the contractor closed the site for construction, but once the weather starts to warm up and the asphalt plants reopen, construction is expected to continue and to be completed in Spring 2024. The Borough is grateful that the County has installed these improvements to improve pedestrian safety in our downtown. The bump-outs at the corners are designed to shorten the pedestrian crossings and eliminate the ability to form a second travel lane. Materials were selected to match the brick and pavers that currently decorate our downtown. Council has coordinated with Heights Grows to install low plantings at each bump-out this Spring. The Haddon Height Safe Routes to School group will team with Cross County Connections for an informational presentation about bike safety in the wake of the improvements. Tax Office - What to look for in 2024

PD5 FORMS – If you are receiving the \$250.00 deduction for qualified Senior Citizens, Disabled persons, or Surviving Spouse, be on alert for the PD5 form in the mail. This form must be completed and returned to the tax office by March 1st to continue receiving the \$250.00 deduction.

PROPERTY TAX REIMBURSEMENT BOOKS – a.k.a. “Senior Freeze.” For residents already enrolled in the program, the State will send you the PTR-2 form directly. For those of you who are not enrolled in the Senior Freeze and who are turning 67+ in 2024, new enrollment books (PTR-1) will be available in the tax office in early April.

ONLINE TAXES – View and/or pay your property taxes online through the borough website at www.haddonhts.com. Now you can see the amount of taxes billed, due, and paid as well as viewing the assessed value of the property.

**** Reminder: First Quarter 2024 tax bills are due February 1st with a 10 day grace period ****

Tax Assessor's Office

New Jersey Law requires the Tax Assessor's office to keep all property assessments current. The Assessor's inspector may visit your property if the property owner or their contractor obtained a building permit to build a new building, or update, improve, expand, remodel, redecorate, rehab and/or demolish an existing building located in Haddon Heights. Please cooperate with the Assessor's inspector who will perform an interior and exterior examination of your home or business, and request information to confirm the type of work done, or to be done, the cost of the project, and the date the job was, or is to be completed. This inspection is in addition to any inspection(s) required by the Haddon Heights Building Inspection Department.

The inspector will visit your property **unannounced** in the day, early evening, or on a Saturday. This method of inspection is very cost effective and I greatly appreciate your help allowing the inspector to collect the data required. The inspectors who work for the Tax Assessor's office are Judith Shoemaker, Jeffery Scott Pierson, and myself. Each inspector will wear an official Haddon Heights Borough ID Badge.

AARP Tax-Aide



Free tax-aide is available at the library every Monday from February 5 - April 15, excluding President's Day. Appointments are required and can be made by calling the library. There are a limited amount of appointments available. AARP Tax-Aide is the nation's largest free, volunteer-run tax assistance and preparation

service. It is available to taxpayers with low and moderate incomes and gives special attention to people age 60 and older.

The program has grown tremendously since it started in 1968 with four volunteers. Approximately 34,600 AARP Tax-Aide volunteers, trained in cooperation with the Internal Revenue Service, now help more than 2.6 million taxpayers file their federal, state, and local tax returns each year. The AARP Tax-Aide program is offered at approximately 6,500

locations nationwide in senior centers, libraries, community centers, and at other convenient locations

Tax-Aide volunteers are trained to assist with filing the 1040 Form and more standard schedules, including Schedules A and B. Taxpayers with complex tax returns are advised to seek paid tax assistance. Electronic filing (e-filing) is offered at most sites, with no charge to the taxpayer. E-filing ensures more accurate tax returns and faster processing of tax refunds.

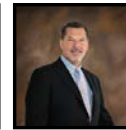

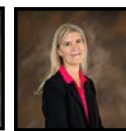

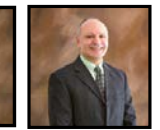
