# MAYOR'S MESSAGE:

Dear Neighbors:

I am sure all were happy that the remnants Hurricane Arthur did not stop one of our town's finest traditions, the annual Independence Day celebration. Although weather delayed the events by a day, the weather turned out to be picture perfect. Our parade and events at Hoff's Park following the Parade were both among the best we have ever had. I want to thank the many volunteers who worked so hard to coordinate these events. I also want to thank our Police Department and Public Works Department for all of the work they did to make this day safe and successful. It was great to see so many of you!

Our Summer Rec Program is in full swing and is once again a resounding success. We have filled just about every available spot for the five (5) weeks the Program runs. Summer Rec is so valuable for a number of reasons; not only does it give our youth great recreational activities right here in our town, it also gives some of our young adults a great

opportunity to have a summer job working with our youth. This program would not exist without the tireless efforts and leadership of Council President Kathy Lange. I would like to personally thank her and her staff for all of their hard work in making this Program such a success and something we all can be proud of.

While we never like to increase taxes, we have to do two (2) things: first, we have to keep up with mandatory costs beyond our control like health care, and second, we need to make sure that we are taking care of our town's infrastructure and assets such as roads, equipment, and sewers. The cost to maintain these items can be high. We need to ask for a modest additional contribution this year in order to maintain our town's level of service.

Finally, with the summer storm season upon us, we have been advised that PSE&G has a new feature on its website to track power outages during storms or other events that result in a loss of power. # BORO BITS

## FROM THE TAX OFFICE...

The deadline for filing your 2012 NJ Property Tax Reimbursement (aka 'Senior Freeze') has been extended to September 15, 2014.

The basic qualifications are:

- You must have been age 65 or older as of 12/31/12
- Lived in NJ continuously since 12/31/02
- Owned and lived in your home Since 12/31/2009
- You must have paid the full amount of the property taxes due on your home:  
For 2012: by 6/1/2013 and For 2013: by 6/1/2014
- Your total annual income must have been:  
For 2012: \$82,880 or less and For 2013: \$84,289 or less (counting social security)

Call the Tax Office 547-7164, ext 30 if you have not applied previously and think you may meet the above qualifications

## OVERNIGHT PARKING

A few reminders about overnight parking:

- Parking is prohibited on Borough streets from midnight to 5:00am.
- Parking Permit applications are available at the Police Department located at 625 Station Avenue.
- 2014 permits must be displayed by 1/1/2014.
- The overnight parking number 856-784-9161. This number is also located on the Borough website several times in case you forget.
- Whenever there is a warning or prediction of possible snow or ice, ALL on-street parking is denied.
