DUMPSTER/POD PLACEMENT POLICY

Permission to place a dumpster/pod on any street is only to be given if there is absolutely no space on the property, including driveway to place a dumpster/pod.

If a dumpster is placed in a driveway, permission to park a vehicle on the street will be given by the Chief of Police if needed to make room for the dumpster/pod.

If the dumpster is to be placed on a State or County Highway, permission from the State or County in writing must accompany this application request.

Display of yellow reflective diamond shaped markers/panels with a minimum size of 18" x 18" must be mounted at both ends of the dumpster nearest the path facing oncoming traffic.

The police department will inspect all dumpsters on any street in the Borough to see if it conforms to N.J.S.S 27:5I-1. A violation of this State Law if convicted could result in a fine of \$100.00 per violation.

If a dumpster must be placed on a street, an application must be made to the Haddon Heights Construction Office accompanied by a \$50.00 fee. No fee is required if the dumpster is placed on private property.

WARNING

A DUMPSTER PLACED ON ANY STREET IN THE BOROUGH WITHOUT FIRST OBTAINING AN APPROVED PERMIT WILL BE REMOVED AND IMPOUNDED UNDER THE AUTHORITY OF THE HADDON HEIGHTS POLICE DEPARTMENT.

GUIDELINES FOR ROLL-OFF CONTAINER MARKINGS

PARKING OF ROLL-OFF DUMPSTERS/PODS OR ROLL-OFF CONTAINERS

N.J.S.A. 27:5I-1

The above-referenced New Jersey Statute applies only to those "roll-off dumpsters" or "rolloff containers" that are placed on the parked roadways, or along any highway, or along any public property.

PURPOSE:

To warn operators of vehicles traveling on public property that they are approaching parked roll-off containers, which require them to exercise unusual care in the operation of their vehicles.

To promote traffic safety on highways or public property.

COMPLIANCE:

Must have written consent to park or leave unattended roll-off dumpsters or roll-off containers on or along any highway or public property. <u>NOTE:</u> Written consent obtained from appropriate municipal, county or state authority having jurisdiction over the highway or public property in question.

Display yellow reflective diamond shaped markers/panels with a minimum size of 18 inches by 18 inches. Marker/panels must be mounted at both ends of dumpsters or containers nearest the path facing oncoming traffic.

Mount marker/panel at the upper end of dumpster or container leaving a minimum height of 3 feet clear distance between bottom of marker/panel and bottom of roadway surface.

PENALTIES:

Violation of this statute carries a fine of not more than \$100.00 per violation.

If there is a default on payment or fine, then imprisonment in the county jail may be imposed for period of not more than 90 days.

IF APPROVED THIS PERMIT WILL BE FOR (30) THIRTY DAYS AND MAY BE RENEWED BY APPROVING AUTHORITY. ALL DUMPSTERS/PODS WILL BE INSPECTED BY THE POLICE DEPARTMENT FOR CONFORMITY TO STATE STATUTES AND OVERALL SAFETY.

ALL DUMPSTERS/PODS MUST BE PLACED ON HOMEONWERS PROPERTY IF THERE IS SPACE AVAILABLE.
