

BOROUGH OF HADDON HEIGHTS COUNCIL WORK SESSION MINUTES

Tuesday, July 2, 2024, 7:00 pm

Mayor Houck called the meeting to Order at 7:00 pm. and then read the following statement:

Mayor Houck asked the Clerk for roll call.

Under roll call, Council President Morgan, Councilmembers Ottoson, Russo, Harron were present as well as Borough Solicitor Howard Long, Borough Clerk, Councilmembers Philipps and Pagan were absent.

BOROUGH ENGINEER'S REPORT:

Craig Reilly, 304 White Horse Pike – submitted written report but highlighted the following:

The next phase of NJDOT Municipal Aid applications were submitted yesterday for the continuation of St. Martins, Wynnefield and New Jersey Avenues. Awards are typically announced in November.

Garden Street Project between 1st and 2nd Avenue – Pre-construction meeting was held this morning. Contractor is set to begin the middle of next week. August 22nd expected substantial completion date. Second phase of that program is E. High Street and Maple Avenue blocks. Engineering Committee project scope comments will be incorporated into the design and the project will be out in next couple of weeks with the hope of bidding it out by the August Council meeting.
