This memorandum serves to provide our office's determination regarding the project submittal by the contractor (Vulcan Construction, Inc.) for the above referenced project.

EQUIPMENT SUBMITTAL - ACCEPTED

Attached is the accepted submittal for the tilling equipment provided by the contractor. Vulcan Construction, Inc. indicated in their submittal that they intend to use:

- 1. Basic Tiller
- 2. Power Landscape Rake or Rockhound Landscape Rake

to "separately rototill 4"-6" deep with the basic Tiller and then to finish with the Power Landscape Rake / Rockhound to remove stones/rocks" to a depth of 2" per the contractor.

The Contract Specifications require in Section 329223 that the contractor "utilize a soil renovator to address the soil compaction to a depth of four (4") inches to five (6") inches" and the equipment used should be a Rotadarion or approved equal. This specified soil renovator is a one step process which buries grass, clods, rocks, and other organic debris while reverse rototilling and conditioning the final soil surface.

Our office has determined the provided multistep process utilizing the submitted basic Tiller – and Power Landscape Rake / RockHound Landscape Rake is an "equal" to the specified Rotadarion soil renovator process for the work effort specified and is therefore acceptable. This determination is based on the limited area that requires tilling / sod installation.

- 1. Till the area to the depth specified in the plans, using a standard tiller
- 2. Use a "Power Landscape Rake" or "Rockhound" attachment which will further level the area and collect all stones and debris to a depth of 2"

RESOLUTION OF THE BOROUGH OF HADDON HEIGHTS, IN THE COUNTY OF CAMDEN, NEW JERSEY AUTHORIZING AN EMERGENCY TEMPORARY APPROPRIATION PURSUANT TO N.J.S.A. 40A:4-20

BACKGROUND

WHEREAS, pursuant to <u>N.J.SA</u>. 40A:4-20, municipalities in the State of New Jersey are permitted, in addition to temporary appropriations necessary for the period prior to the adoption of the budget and regular appropriations, to make emergency temporary appropriations for any purposes for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for the current fiscal year; and

WHEREAS, the Borough Council of the Borough of Haddon Heights, County of Camden, New Jersey ("Borough") has not heretofore adopted the budget for the current fiscal year; and

WHEREAS, the Borough desires to appropriate \$25,000 to temporarily fund the Camden County Open Space Infield Improvements at Fitzgerald Memorial Park Project; and

WHEREAS, such emergency temporary appropriation shall be included under the correct headings in the budget when adopted; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOROUGH COUNCIL OF THE BOROUGH OF HADDON HEIGHTS, IN THE COUNTY OF CAMDEN, STATE OF NEW JERSEY (NOT LESS THAN TWO-THIRDS OF ALL THE MEMBERS THEREOF AFFIRMATIVELY CONCURRING), AS FOLLOWS:

- <u>Section 1</u>. An emergency temporary appropriation in the amount of \$35,000 to fund the Borough's Capital Improvement Fund ("Emergency Temporary Appropriation"), in accordance with Section 20 of the Local Budget Law, <u>N.J.S.A.</u> 40A:4-20, is hereby authorized and approved.
- <u>Section 2</u>. The amount of such Emergency Temporary Appropriation shall be included under corresponding headings in the budget as adopted or, if such Emergency Temporary Appropriation is adopted after the introduction and approval of the budget and was not included in the budget as approved such Emergency Temporary Appropriation shall be included by amendment in the budget as adopted without public advertisement or public hearing.
